



Commonwealth Woodstove Change-Out Program

2017 Eligible Stove List

All stoves on the following list may be installed under the 2017 Commonwealth Woodstove Change-Out Program. Stoves are listed alphabetically by manufacturer and model. Please note that some stoves may be listed under a different manufacturer (for example, Vermont Castings stoves are included under Monessen Hearth Systems Company).

To find your stove on this list:

1. Press CTRL+F (or CMD+F if using a Mac) to search this page
2. Search for a distinct segment of the name of the stove you plan to install. For example, to find the Enviro M55C stove, you could type in "55c"
3. Press enter until you see the correct stove
4. Copy and paste the Stove ID, including dashes, into the correct field on the application
5. If your stove does not appear when you search, try searching a different word in the stove name

Stove IDs have been assigned using the convention below. When entering a stove ID in the application, please check that the stove prefix matches the value of the rebate for which you are applying. For instance, a stove with the stove ID prefix "NC3E-" would be eligible for the \$500 Standard Rebate or the \$1,500 Income-Based Rebate *and* the \$250 efficiency adder, whereas "NC3N-" would not be eligible for the efficiency adder. Before submitting your application, please confirm that the stove ID you entered matches the one in this document.
